- **District Development Committee Update**

- The applications for grants supporting events May - October, 2024 are currently open and the District Development Committee will be reviewing the applications on March 20 in preparation for the March board meeting.

- **HTID Marketing Committee Updates**

Current Projects Updates:

- *Meeting with Lodging Partners* - Since the last meeting, Jessica has found the owners of all the rentals in town and will be reaching out to get more information so we can include them on the website. She is also scheduling calls and meetings with all the lodging partners to build a comprehensive database that lists the exact amount of rooms, meeting spaces, etc.
- *Update on RFP for Digital Marketing Services* - Jessica has met with a couple different agencies and they will be submitting all proposals by the end of the month. This includes the agency for Visit Carmel, Visit Laguna Beach, and Travel Paso.
- *Trade Show Booth Designs* - The committee has decided on a trade show booth style and we are just finalizing the artwork.
- *Brand Video Complete* - Since we last met, the brand video is now complete and final. Jessica will send it to the board.
- *Partnership with Healdsburg Wine & Food Experience* - Jessica is working with the Healdsburg Wine & Food Experience to figure out Stay Healdsburg's presence. Ideally, we will sponsor one of the lounge areas.
- *Season to Sparkle* - The committee is starting to work on the holiday activations, including the Season to Sparkle. We will create a full marketing and communications plan around the season and include all businesses in town. The idea is to create an entire season where something is happening everyday, whether it is events, special deals, special menu items, etc. We are also working on a multi-night overnight incentive option.
